## Investment in Affordable Housing 2014-19 Extension Agreement Annual Report on Outcomes, 2017-18

In 2014, the Governments of Canada and New Brunswick announced a combined investment of \$78 million under the Investment in Affordable Housing Extension Agreement. Over the 2017-18 year, this joint initiative has helped build and repair 1,607 affordable housing units in New Brunswick for low-income individuals, families, seniors and persons with disabilities.

Under the terms of the agreement, New Brunswick Housing Corporation will publicly report, annually, on how funding has been spent and how progress has been achieved in meeting the objectives outlined within the agreement.

The following are outcomes from 2017-18 of the program, which saw approximately \$15.9 million in funding committed throughout the province.
